#### Treasurer Report- Alan Kirpes

Net Income YTD 6/30/10 is <\$188.37> which is on target with budget. Bank account balances as of 8/31/10 are \$10,961.97 for IWMSC and \$445.71 for HMS.

#### Registrar Report- Mark Taylor

There are 310 registered swimmers. Budget for 2010 based on 300 full year registrations and 20 late year registrations.

## **IWMSC Fees**

#### Membership fee structure.

The following membership fee structure was approved for 2011 registrations:

- Full Year- \$40, consisting of \$29 USMS, \$10 LMSC, \$1 Club.
- End of Year- \$30, consisting of \$24 USMS, \$5 LMSC, \$1 Club.
- Discounts by LMSC
- Senior 60+ full year \$4, end of year \$0
- Junior 18-24 full year \$4, end of year \$0
- One event \$15, consisting of \$12 USMS, \$3 LMSC
- Club Fees \$30, consisting of \$30 USMS, \$0 LMSC

With increase in USMS fee anticipated for 2012, the idea for 2012 is to leave IWMSC full fee at \$40 with LMSC reducing its portion in an amount equal to the increase in the USMS, subject to an acceptable LMSC budget.

# Sanction fee structure.

LMSC sanction structure was changed to a flat fee. Host team is to determine the meet fee with new structure. IWMSC will no longer determine meet fee. The following sanction fees per entrant were approved beginning 1/1/11:
